

Articles of The Rigamarole

Based in Stockholm
Established 2019

Purpose and Aim

The goal of the organisation is to run an annual event held in Stockholm for Balboa dancers with the intent of:

- Inspiring and engaging the local Balboa dance community
- Attracting and facilitating contact between the local, regional, and international Balboa dance communities

The organisation's events will be open to adult members of the Balboa dancing community.

The organisation will operate all its events as safe spaces.

The organisation will operate on a non-profit basis.

Financials

Hanna Minter acts as Firmatecknare (founder). The Firmatecknare has the right to enter into contracts on behalf of the organisation. Both Firmatecknare and Kassör (treasurer) have independent control over and administrative responsibility for the bank accounts and other financial aspects of the organisation. The holder of the role of Kassör can be changed at the discretion of the board/election. Initially the role of Kassör will be held by David Minter.

Membership

The membership of The Rigamarole will be divided between voting and non-voting members.

The board will be constituted of a minimum of three and a maximum of five members.

Members of the board of The Rigamarole will have voting rights.

Individuals otherwise actively involved in the running of the event ('volunteers') will be eligible for non-voting membership.

It is also open to the board to offer non-voting membership to other persons.

After a minimum time commitment decided upon by the board, non-voting members will be eligible to nominate members to the board via the election committee (see section 'Voting Rights').

The board has the right to offer and reject membership.

Reasons to expel a member from the organisation include, but are not limited to:

- Not following the terms and conditions of membership, including
 - Not following the established safe spaces policy of the organisation
 - Non payment of membership or other fees established by the board
 - Non-fulfillment of agreed upon and allotted volunteer hours

Members of The Rigamarole (including the board) can send an email to The Rigamarole's administration address in order to leave the organisation voluntarily.

Expulsion of a member

If the board decides to exclude a member then that member must for at least 14 days have the opportunity to challenge the decision and offer comments on the circumstances leading to their ejection.

Any decision to expel a member must be communicated to that member in writing within three days of the decision. The notification must state the reasons for the decision and how the member can appeal the decision.

Members Rights & Obligations

Members of the organisation have the rights to:

- Participate in activities set up for members
- Receive information about the organisation's business

Members of the organisation do not have the rights to:

- Income or property of the organisation
 - Including in the event of its dissolution

Members of the organisation have the obligation to:

- Follow these articles

- Follow the decisions of the board
- Pay membership or other fees decided upon by the board
- Fulfill their individually agreed upon volunteer hours and responsibilities
- Accept GDPR compliant handling of their personal data by the organisation
- Follow the GDPR decisions of the board as advised by the Data Protection Officer

Voting Rights

- Members of the board have voting rights
- The board may offer voting rights to volunteers who have made a significant contribution
- The entire membership can nominate members for the board via the election committee
- The election committee proposes the candidates they deem suitable to the board
- The board votes on acceptance of candidates to the board
- Change in the make-up of the board is constrained to one third of the total numbers to ensure the continuity of knowledge and experience
- The board will be elected at the AGM to be held each year
- The next election will be on 1st December 2020

Decisions and Voting



Decisions can be made by acclamation or if so requested by a vote.

Elections are decided by a relative majority. A relative majority vote is carried when a given candidate or decision receives more votes than the other candidates or decisions.

Other issues are decided by an absolute majority. An absolute majority vote is carried when a given decision receives more than fifty percent of the votes.

Voting is carried out openly unless a member requests that it be executed as a secret ballot.

The minutes of official meetings including the AGM will be published and include decisions of the board.
